#### 1. Definition: -

<u>Bus: -</u> Stage carriage bus with seating capacity ranging from 24 seats to 46

seats.

**Age:** - Age of the bus from the date of registration.

**<u>Kms: -</u>** Route Kms operated from bus stand or night stay place to other point.

**Dead Kms:** - Kms run by bus from maintenance, HSD filling etc. Non-revenue Kms.

Authority: - Kadamba Transport Corporation Ltd.

**SPV: -** Kadamba Transport Corporation Ltd.

**Operator:** - Owner of the bus, Association of bus owners, company or society.

RTA: - RTA having jurisdiction Canacona, Quepem, Ponda and buses

operating under this Jurisdiction.

M. D.: - Managing Director of KTCL.

**G. M.:** - General Manager of KTCL.

Scheme: - "Maji Bus Yojana"

#### 2. Operating Parameters: -

- a. Minimum assured Kms/Day 180 Kms.
- b. Extra Kms...... Kms above 180 Kms.
- c. Rate per Kms payable.

- d. Rate for Extra Kms= 60 % of above rates.
- e. Operation days per year = 335 days

- g. If required may extend operation days upto 365 days.
- h. Pilot scheme period 6 months from 1<sup>st</sup> July 2023 to 31<sup>st</sup> December 2023. If required will be extended.

#### 3. Responsibilities of Operator: -

- a. Download and fill application on website ( <u>www.ktclgoa.com</u>) and upload same with all details and enclosures.
- b. Provide experience driver with bus.
- c. Maintain and keep the bus clean.
- d. Pay Passenger Tax, Road Tax, etc.
- e. Driver shall be registered with PF & ESIC.
- f. To park bus at bus stand for departure, 20 minutes before departure by driver.
- g. Shall deposit Rs.5000/- as security deposit with application form.
- h. Valid Insurance, Comprehensive or third party, required to be taken.
- i. Should operate bus on schedule route allotted by authority.
- j. In case breakdowns, bus should be repaired immediately to operate the further route.
- k. In case of accident, all claims, damages and court settlements should be done.

  Authority is not responsible for any claim.
- Should be responsible for damage or loss occurred to bus in case of agitation, accident and while in operation.
- m. Shall pay wages to drivers and deposit PF, ESIC, Gratuity contribution from time to time and submit the receipt to the office of Authority.
- n. Should not employ drivers, who is terminated, dismissed by Authority, having criminal back ground, sick or medically unfit driver.
- o. Shall submit status report of Accident to Authority, immediate relief to patients, Crew, etc and claim progress report from time to time.
- p. Should abide by all Act/Rules prevailing in Goa like MV ACT, MV workers ACT, PF ACT, Gratuity ACT, etc. applicable to workmen. Authority will help to comply to it.
- q. Should submit fortnightly bill to Authority on 18<sup>th</sup> and 3<sup>rd</sup> day of every month in bill format given by Authority.
- r. Payment will be done within 7 days on receipt of the bill by Authority.
- s. Should not sale or dispose vehicle while operating under the scheme without permission of Authority.

- t. No diversion from route or operation of bus is allowed, unless Authorized by Authority. The Authority will decide about revenue sharing in case of diversion or contract operator.
- u. Shall allow to mount/fix VLTD device, CCTV or any electronic unit or machine to read and record operation for safety and security.
- v. Shall provide fire extinguishers & FA box in the bus.
- w. Shall surrender original permit with authority till the bus is operated under this scheme.
- x. Should pay fine & penalty, issued by Police, RTO etc.
- y. Should not allow to carry the contraband goods in bus by driver.
- z. Should repair and paint bus in case damages during accident.
- aa. Should be responsible for safety and security of bus at all time.
- ab. Driver deployed will have to use ATM machine for ticketing if requested by Authority. Authority will train them. Driver shall be responsible to collect cash and issue ticket.
- ac. Should maintain log books of operation of bus under the scheme.
- ad. Bus should have stepney Tyre and necessary basic tools like jack, levers etc.

#### 4. Responsibility of Authority: -

- a) Will provide schedule copy to operate the bus.
- b) Night stay will be given to operate, operator should abide by it.
- c) Conductor and ATM ticketing machine will be provided by Authority.
- d) To pay advances as well as final payment to operator on submission of Bill, after verification.
- e) Assist operator, for operation, to pay Taxes, to comply the ACT & Rules in force if required.
- f) Mount VLTD Devices, CCTV and panic button, PAS system, Digital boards, ATM machine on buses.
- g) Provide /extend facility of concessions, Pass System facility, Reserved Seats to beneficiaries on the buses under the scheme.
- h) Provide log book to bus to maintain and record day today Kms, operated, other records of accident, breakdown, departure, etc. Cleanliness record.

- i) To penalize operator for default if any.
- j) Maintain and submit monthly report to Review Committee for appointed by DOT.
- k) Reserve right to allot, divert schedule route, trips also Divert bus for casual contract on revenue sharing basis with operator, in and outside Goa.
- I) To deduct penalty from Bill amount or Security Deposit.
- m) Will provide required necessary instruction sticker or awareness sticker to paste inside the bus.
- n) Will provide color code, logo, etc.....

#### 5. Responsibility of Driver: -

- a) Should possess valid driving License.
- b) Should carry xerox copy of all documents while on duty.
- c) Should not drink or consume alcohol/tobacco products/drugs while on duty.
- d) If diabetic should inform KTCL Authority about same, before joining.
- e) Behave politely with commuters, conductors and Authority, give respect to all concern.
- f) Drive the bus with speed limit and obey all traffic, Rules.
- g) Help conductor during accident to transfer patients.
- h) Should have call number. Of operator, Emergency number, Ambulance number, Authority.
- i) Should be punctual and wear uniform while on duty.
- j) Maintain bus, seats of the bus clean and hygienic.
- k) Destination Board should be properly displayed.
- Should keep records of operations of Kms in log book & take sign of Authority daily.

#### 6. Dispute: -

Any dispute arising out during the scheme in force, in connection with operation, payment, will be settled amicably before M.D. KTCL or otherwise shall be instituted and exclusive trail by the court at jurisdiction of Panaji- Goa.
