GENERAL GUIDELINES

1. The upper age limit for posts, **at Sr. No. 1 and 3 to 5, shall not exceed 45 years**, while for the post at **Sr. No. 2, the upper age limit shall not exceed 30 years**, in both cases **as on the date of advertisement**. However, the upper age limit shall be relaxable by up to five years in respect of Government Servants, in accordance with the instructions or orders issued by the Government from time to time. Further, age relaxation shall be admissible to candidates belonging to the reserved categories, namely, five years for Scheduled Caste (SC) and Scheduled Tribe (ST) candidates, three years for Other Backward Classes (OBC) candidates, and ten years for Persons with Disabilities (PwD). PwD candidates belonging to the SC/ST category shall be entitled to an age relaxation of 15 years, while PwD candidates belonging to the OBC category shall be entitled to an age relaxation of 13 years, subject to the instructions or orders issued by the Government from time to time.
- 2.All applicants must have knowledge of English, Hindi, Konkani, and Marathi.

3. Candidates applying for the post must submit the application in the prescribed format along with self-attested copies of the following documents:

1. Birth Certificate
2. Educational Qualification Certificates
3. Experience Certificates
4. Valid Employment Registration Card
5. 15 Years Residence Certificate in Goa issued by the Competent Authority
6. Valid Category Certificate issued by the Competent Authority (if applicable)
7. One recent Passport size photograph affixed on the application form
8. Any other relevant document

4. **The Application form will be available at KTCL Head Office between 10.30 a.m. to 05.00 p.m.** (lunch break 1:00 p.m. to 02:00 p.m.) **on payment of Rs.100/- for Unreserved category and Rs. 50/- for Reserved category.** A separate application should be submitted for each category of posts.

5. Application Form filled in with necessary details along with the documents and affixed with his/her recent self-attested passport size photograph on the space provided and duly signed at the bottom of the Application form shall be submitted by hand delivery/postal delivery in the **Parasio De Goa, Alto Porvorim, Bardez – Goa Pin Code – 403521** by **11/09/2026** between **10.30 a.m. to 05.00 p.m.** (lunch break 1:00 p.m. to 02:00 p.m.) **the hard copy of the application form received after the due date will be summarily rejected.**

6. Only the eligible candidates fulfilling the criteria's as per recruitment rules/advertisement shall apply. However, the candidature of shortlisted candidates shall not be considered, if he/she is found ineligible at the time of verification of essential documents, even though he/she has passed the examination.

7. Only application will be accepted with declaration from candidates stating that "the contents of the applications are true to his/her own knowledge and he/she possess the requisite qualification and other mandatory documents for the posts. He/ She understand that in the event of particulars or information given, herein being found false or incorrect, his/her candidature for the recruitment is liable to be **"Rejected or Cancelled Even After Selection"**.

8. Only qualified candidates shall be called for written examination. The total marks of written examination shall be 70 (for post at sr. no.1,2,3 and 5) and post at sr. 4 will carry 50 marks for written examination and 20 marks for computer test.

9. The selection of candidates shall be determined on the basis of the total marks obtained by each candidate in the written examination for the posts at Sr. Nos. 1, 2, 3 and 5. In respect of the post at Sr. No. 4, candidates securing the requisite qualifying marks in the written examination shall be further called for the Computer Test, and the selection shall be determined in accordance with the marks obtained in the written examination and the Computer Test, as applicable. The complete result shall be published on the Notice Board of the Department as well as on the official websites of the Corporation, **ktclgoa.com**, and the Government of Goa, **www.goa.gov.in**.

10. If two or more candidates secure equal marks in the written examination then order of merit shall be as per their date of birth and if in case the date of birth is also same, then the candidate possessing higher educational qualification will be placed higher in the merit list.

11. The candidates already working in the Government, Local Self Government, Semi Government autonomous bodies or establishment or any other department establishment or institution being an instrument of the Government should send their application through proper channel only.

12. The crucial date for determining the eligibility as to the educational qualification, age, valid domicile/residence certificate, valid employment card, caste certificate, etc. shall be **11/09/2026** (closing date) for appointment to the above posts.

13. Interested candidates should ensure that they are fulfilling the educational qualification/criteria prescribed for the above posts with the valid certificate of qualification, computer literacy certificate, experience certificate, 15 years and Birth Certificate Caste

14. No TA/DA will be paid either for appearing for written examination/computer test.

15. The KTCL reserves the right to cancel the recruitment process at any time without any further notice and without assigning any reason thereof.
